- · Lack of faith on pharmacists.
- Home Medicine Review awareness is lacking among general public.
- Patients with no health care takers may suspect pharmacists as strangers, in spite of approaching in good appearance to patient destination.
- Until and unless, patient medical condition is unstable which needs to have frequent monitoring, this type of health care services becomes less significant.

Other difficulties that may be encountered while carrying out this research work are:

- Until and unless local language is known, one may not be able to collect clear case history of patient.
- At last moment, patient will not permit to have medication review in home without any valid reason.

- Some patients deliberately make their telephonic number unreachable without any valid reason.
- Sometimes health care takers of patient may give false information about patient, stating that patient is out of station, in spite of patient is present in home.
- Pharmacist not be able to reach patient destination sometimes in correct schedule time due to more vehicle moments on the road.
- Some patient may be unwilling to give complete information to pharmacist, without any valid reason.
- False perception among general public where pharmacists are underestimated in such a way that they are meant only for dispensing and selling medications.
- Pharmacist may not be able to meet patient expectations in all the times, making patient to get frustrated.

Benefits of Home Medicine Review:

- Awareness will be created to patient with regarding to disease and medication aspects.
- Patients with no health care clinic from their respective residential destination will be the one who can be more benefitted.
- Patients with no health care takers may have more advantage with this type of health care programme.
- Patients with hearing and vision problem without any health care takers may be more benefitted from this type of health care programme.
- Patients suffering from more than four to five comorbidities may be more benefitted from this type of health care programme.

This type of health care services should be more applicable for patients having more medical follow ups followed by lack of transport facilities from patient home destination to consultant destination.
- Patient with poor literacy status can be more benefitted with this type of health care programme.
- The collaboration between pharmacist and general physician can be established, depending upon how pharmacist executes this health care programme at the point of delivery.

One of the research works carried out in Australia with respect to Home Medicine Review reflects that following problems were observed ¹.

 Hospitalisation due to adverse drug events among general population were accountable for 5.6% followed by elderly patients was accountable for 30.4%.

- According to this research study medication adherence among patients was accountable for 50-60%.
- Patients with poor literacy rate have difficulty in understanding health information in according to research investigator of this research study.
- The importance of Home Medicine Review in according to research investigator of this research study was to reduce irrational use of medicines.
